Personal data that we process

Emiss Mobile Systems BV processes and collects personal data when:

- You leave information yourself via the contact form on our website;

This concerns the following personal data:

- First and last name
- Email address
- Company name
- Phone number
- Other personal data that you actively provide via the contact form on our website.

Personal data is only shared with third parties when this is necessary for an external party to perform services on our behalf or to comply with any legal obligation. When personal data is shared, we always enter into a processing agreement with the external party to ensure that your data is processed with the same level of security and confidentiality. Emiss Mobile Systems BV always remains responsible for these processes.



Purpose and basis for processing personal data

Emoss Mobile Systems BV processes your personal data for the following purposes:

- To be able to call or email you if this is necessary to provide our services;
- To inform you about the range of - or changes to - our products and services;
- Sending a newsletter and/or advertising brochure.

How long we keep personal data

The data will be stored and used for a period in accordance with applicable legislation.

Cookies, or similar techniques, that we use

Emoss Mobile Systems BV only uses technical and functional cookies. And analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preference settings. We can also optimize our website with this. You can unsubscribe from cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via the settings of your browser.

On your first visit to our website, we already informed you about these cookies and asked your permission to place them.

View, adjust or delete data

You have the right to view, correct or delete your personal data. You can do this yourself by contacting EMOSS via info@emoss.nl. In addition, you have the right to withdraw your consent to data processing or to object to the processing of your personal data by our company and you have the right to data portability. This means that you can submit a request to us to send the personal data we have about you in a computer file to you or another organization mentioned by you.

If you would like to exercise your right to object and/or right to data portability or if you have other questions/comments about data processing, please send a specified request to info@emoss.nl.



To ensure that the request for access has been made by you, we ask you to enclose a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This is to protect your privacy. EMOSS will respond to your request as quickly as possible, but in any case within four weeks. The copy of the ID will be deleted immediately after the request has been processed.
